**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of May 1, 2006, from JPMorgan Chase Bank, a national banking association, as Administrative Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to Wirekraft Industries, L.L.C., a Delaware limited liability company (formerly known as Wirekraft Industries, Inc.) ("Company").

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of January 31, 2003, made by the Grantors (as defined therein) in favor of the Agent (the "Collateral Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including U.S. trademark registration 1,691,163 (WIREKRAFT) and U.S. trademark registration 1,713,207 (BURCLIFF INDUSTRIES) (the "Trademarks");

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights dated as of January 31, 2003, among the Agent and the Company (the "Security Agreement"), the Company, by reference to the Collateral Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in the Trademarks;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on February 6, 2003, at Reel 2667 and Frame 0041; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Agent hereby states as follows:

1. The Agent hereby terminates, releases and discharges its Security Interest in the Trademarks, and any right, title or interest of the Agent in the Trademarks shall hereby cease and become void.
2. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
