**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of April 28, 2006, from JPMorgan Chase Bank, N.A., a national banking association (formerly known as Chemical Bank), as Administrative Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to Wirekraft Industries, L.L.C., a Delaware limited liability company (formerly known as Wirekraft Industries, Inc.) ("Company").

WITNESSETH:

WHEREAS, pursuant to the [Name of Security Agreement, e.g. Guarantee and Collateral Agreement], dated as of [Date], made by the Grantors (as defined therein) in favor of the Agent (the "Collateral Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including U.S. trademark registration 1,691,163 (WIREKRAFT) and U.S. trademark registration 1,713,207 (BURCLIFF INDUSTRIES) (the "Trademarks");

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office on June 16, 1995, at Reel 1370 and Frame 0250; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Agent hereby states as follows:

1. The Agent hereby terminates, releases and discharges its Security Interest in the Trademarks, and any right, title or interest of the Agent in the Trademarks shall hereby cease and become void.
2. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.


