Dear Mr. Garten:



This letter will also evidence the agreement of Licensor and Licensee that the purchase price shall be due and payable in full on or before four (4) years from Effective Date with interest to accrue at the rate of per annum.

Licensee shall make self-liquidating payments of principal and interest on a quarterly basis in the second through fourth years of the Term, with each of twelve (12) payments in the amount of not less than

In the event the Purchase Price is prepaid at any time, Licensee shall pay the principal owed to the date of payment plus interest due and payable from the date of the most recent quarterly payment of both interest and principal


