ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT

ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT ("Assignment"), dated March 3, 2006, by **Heller Financial, Inc.**, a Delaware corporation, in its capacity as Agent for Lenders, and **General Electric Capital Corporation**, a Delaware corporation, as successor Agent for the Lenders.

WITNESSETH:

WHEREAS, **Randall-Reilly Publishing Company, LLC**, f/k/a **RPC Acquisition Company, LLC**, a Delaware limited liability company ("Borrower"), the other Credit Parties signatory thereto, the Lenders signatory thereto from time to time and Heller Financial, Inc. are parties to that certain Credit Agreement, dated as of November 1, 2005, as amended by the Joinder Agreement, Consent and First Amendment to Credit Agreement, dated as of January 31, 2006 and as further amended by that Second Amendment And Waiver To Credit Agreement, dated as of February 15, 2006 (as it may be further amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"; capitalized terms used herein and not defined herein have the meanings assigned to them in the Credit Agreement);

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of November 1, 2005, by Borrower in favor of Heller Financial, Inc., Borrower granted to Heller Financial, Inc., on behalf of itself and Lenders, a continuing first priority security interest in all of Borrower's right, title and interest in, to and under the following, whether then existing or thereafter created or acquired (collectively, the "Trademark Collateral"): (a) all of its Trademarks and Trademark Licenses to which it is a party, including those referred to on Schedule I hereto; (b) all reissues, continuations or extensions of the foregoing; (c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and (d) all products and proceeds of the foregoing, including, without limitation, any claim by Borrower against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License; and

WHEREAS, pursuant that certain Second Amendment And Waiver To Credit Agreement ("Second Amendment") entered into as of February 15, 2006 ("Second Amendment Effective Date"), by and among Borrower, the other Credit Parties signatory thereto, the Lenders signatory thereto, Heller Financial, Inc. and General Electric Capital Corporation:

1. Heller Financial, Inc. resigned, effective as of the Second Amendment Effective Date, its position as Agent under the Credit Agreement and the other Loan Documents;
2. The Required Lenders appointed, effective as of the Second Amendment Effective Date, General Electric Capital Corporation as successor Agent under the

Credit Agreement and the other Loan Documents;

3. General Electric Capital Corporation, by signing the Second Amendment, accepted that appointment as successor Agent;

4. Borrower, by signing the Second Amendment, acknowledged the appointment of General Electric Capital Corporation as the successor Agent;

5. By virtue of the appointment of General Electric Capital Corporation as successor Agent and its acceptance of such position, General Electric Capital Corporation, as of the Second Amendment Effective Date, succeeded to and became vested with all the rights, powers, privileges and duties of Heller Financial, Inc. under the Credit Agreement and the other Loan Documents, and Heller Financial, Inc. has been discharged from all of its duties and obligations as Agent under the Credit Agreement and the other Loan Documents, except that General Electric Capital Corporation shall have no responsibility or liability for any actions taken or omitted to be taken by Heller Financial, Inc. as Agent under the Credit Agreement or the other Loan Documents; and

6. Heller Financial, Inc. is required to execute and deliver to General Electric Capital Corporation this Assignment.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Heller Financial, Inc. hereby assigns, conveys, and transfers unto General Electric Capital Corporation as successor Agent its entire continuing first priority security interest in all of Borrower's right, title and interest in, to and under the Trademark Collateral as specified in the Trademark Security Agreement. This Assignment is expressly made NUNC PRO TUNC to have the same legal force and effect as if executed on February 15, 2006.
