INSTRUMENT OF ASSIGNMENT AND ACCEPTANCE
OF SERVICE MARKS AGREEMENT

This INSTRUMENT OF ASSIGNMENT AND ACCEPTANCE dated as of May 8, 2006 (this "Assignment") is between Credit Suisse, Cayman Islands Branch (f/k/a Credit Suisse First Boston, Cayman Islands Branch), as Administrative Agent (the "Assignor"), and Credit Suisse, Cayman Islands Branch, as the Collateral Agent (the "Assignee").

WITNESSETH:

WHEREAS, the Assignor was the administrative agent under that certain Amended and Restated Credit Agreement (the "Credit Agreement") dated as of June 11, 2004, among LBI Media, Inc. (the "Borrower"), the guarantors party thereto (including Liberman Broadcasting, Inc. and KRCA Television, Inc., the "Guarantors"), and collectively with the Borrower, the "Credit Parties"), the lenders and the agents party thereto;

WHEREAS, the Assignor was the grantee under the Collateral Documents (as defined in the Credit Agreement), including without limitation that certain Service Marks Agreement dated as of July 9, 2002, between Liberman Broadcasting, Inc. and Fleet National Bank, as predecessor administrative agent and that certain Service Marks and Trademarks Agreement dated as of July 12, 2004 among Liberman Broadcasting, Inc., KRCA Television, Inc. and the Assignor (collectively, the "Service Marks Agreements") securing the obligations of the Borrower and the Guarantors under the Credit Agreement and the other Loan Documents (as defined in the Credit Agreement);

WHEREAS, on the date hereof, the Assignor transferred and assigned all of its rights, powers, privileges and duties in respect of the Collateral Documents to the Assignee;

WHEREAS, the Assignee, will succeed to the estates, properties, interests, rights, powers, and duties of the Assignor in, to and under the Collateral Documents;

NOW, THEREFORE, in consideration of the premises and mutual agreements herein contained and other good and valuable consideration, receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. The Assignor hereby assigns and transfers irrevocably to the Assignee, in its capacity as collateral agent and as grantee under the Service Marks Agreements, and its successors and assigns, all the properties, rights, powers and duties of the Assignor in, to and under the Service Marks Agreements, and the security interest in all service marks of each party to the Service Marks Agreements, either owned by or assigned to such party, including with out limitation the registrations and/or applications for registration of the Service Marks set forth on Schedule A attached hereto.

2. The Assignee hereby accepts such assignment and accepts all the properties, rights, powers and duties of the Assignor under and pursuant to the Service Marks Agreements, and the security interest in all service marks of each party to the Service Marks Agreements, either owned by or assigned to such party, including with out limitation the registrations and/or applications for registration of the Service Marks set forth on Schedule A attached hereto.

3. The Assignor will, at the expense of the Credit Parties and at any time and from time to time, promptly execute and deliver all further instruments and documents, and take all further action, that may be necessary or desirable, or that the Assignee may reasonably request, in order to transfer any of the properties, rights, powers and duties granted or purported to be granted hereby or to enable the Assignee to exercise and enforce its rights and remedies under the Service Marks Agreements.


4. This Assignment shall in all respects be governed by, and construed in accordance with, the law of the State of New York, including all matters of construction, validity and performance.


5. This Assignment may be executed in counterparts, each of which when executed and delivered shall be deemed an original, and all such counterparts shall constitute one and the same instrument.


