ASSIGNOR hereby also agrees to promptly execute and deliver to ASSIGNEE or its legal representative any papers, instruments, affidavits, or other documents that legally may be required or desired by ASSIGNEE in connection with the filing, prosecution, maintenance, defense, and enforcement of any rights in the Marks in the United States and in any foreign countries, including additional documents that may be reasonably required to affirm the rights of ASSIGNEE in and to any said Marks, all without further consideration.

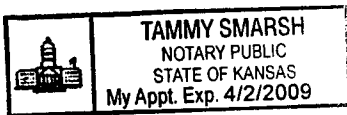
