ASSIGNMENT OF COPYRIGHTS, TRADEMARKS, SERVICEMARKS AND PATENTS

Pursuant to the Agreement, Assignor has agreed to execute such instruments of assignment as Assignee may reasonably request.

B. Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, (i) all of Assignor's worldwide right, title and interest in and to all of Assignor's domestic and foreign copyrights, both in published and unpublished works, copyright registrations, and copyright applications (ii) all of Assignor's worldwide right, title and interest in, to and under Assignor's name, Assignor's registered and unregistered domestic and foreign trademarks, trade names and servicemarks, all associated registrations and applications therefor and any renewals and extensions thereof, and any assumed fictional business names, including those properties listed on Schedule A, attached (all of the foregoing being referred to herein as the "Marks"), and (iii) all of Assignor's worldwide right, title and interest in, to and under all patents, all associated registrations and applications therefor and any renewals and extensions thereof, including those registered or pending in the United States Patent and Trademark Office, including those listed on Schedule B, attached (all of the foregoing being referred to herein as the "Patents").

AGREEMENT

Assignor, for and in acknowledgment of receipt of the consideration set forth in the Agreement, hereby transfers and assigns to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under the Copyrights, the Marks and the Patents, and all causes of action, rights of recovery and claims for damages and other relief referring or pertaining to the Copyrights, the Marks and the Patents, including claims for past and future infringement, that may hereafter be secured under any law in any jurisdiction, the same to be held and enjoyed by Assignee, its successors and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

Except to the extent that federal law preempts state law with respect to the matters covered by this Assignment, it will be governed by and construed under the laws of Illinois without regard to conflicts of laws principles that would require the application of any other law.

Assignor has executed and delivered this Assignment as of the date indicated in the first sentence of this Assignment.
