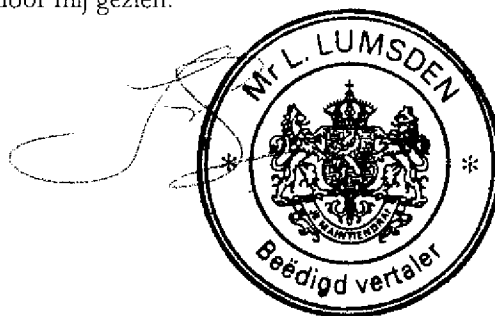

Box 1, 7490 AA Delden), for which amendment to the Articles of Association the Declaration of No-Objection was granted by the State Secretary of Justice on the seventh of July two thousand and four, number B.V. 34.103,  
and requests the Honourable Custodian of Mortgages in Zwolle to authorise him, as far as is required, to put in the cadastral register(s) all immovable properties, recorded in the name of the aforementioned private limited liability company, in the name of the private limited liability company: **Elementis Specialties Netherlands B.V.**, having its registered office in Delden, municipality of Hof van Twente.
