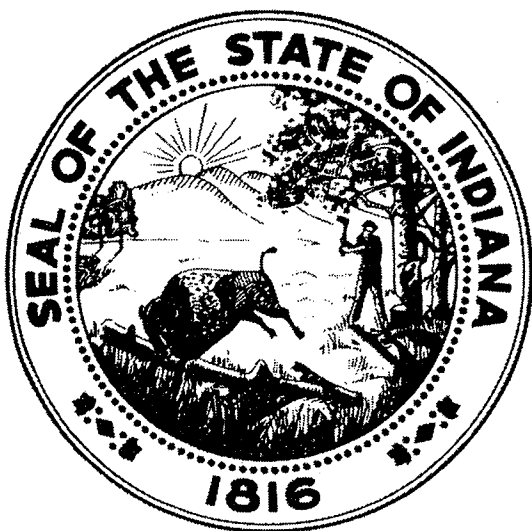

These Articles of Amendment to the Articles of Incorporation of SMP Acquisition Co., Inc., a corporation organized under the Indiana Business Corporation Law (the "Corporation"), are executed by the President of the Corporation for the purpose of amending the Corporation's Articles of Incorporation.

2. Article 1 of the Articles of Incorporation is hereby amended to change the name of the Corporation as follows:


The name of the Corporation shall be Sun Components, Inc.
