NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, GE Capital does hereby acknowledge that Miltex Dental has satisfied its obligations referenced herein and GE Capital hereby releases all right, title and interest in and to the Trademark Collateral (as defined in the Agreement), including without limitation the trademarks listed in Schedule 1 attached hereto, together with the goodwill of the business symbolized by the Trademark Collateral and the registration thereof, and all products and proceeds thereof, including without limitation, any and all causes of action which may exist by reason of infringement thereof.


