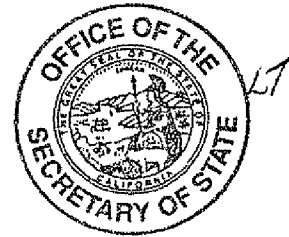

CERTIFICATE OF AMENDMENT OF  
AMENDED AND RESTATED ARTICLES OF INCORPORATION OF  
V STAR CORPORATION

The undersigned, Steve Fowler, hereby certifies that:

1. He is the duly elected and acting President and Secretary of V Star Corporation, a California corporation.
2. Article I of the Amended and Restated Articles of Incorporation of this corporation shall be amended to read in its entirety as follows:


**"ARTICLE I**

The name of this corporation is GoTV Networks, Inc. (the "Corporation")."

3. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the Board of Directors.
4. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Sections 902 and 903 of the California General Corporation Law. The total number of outstanding shares of the corporation is 48,696,008 shares of Common Stock and 92,147,650 shares of Series A Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required under law and the Amended and Restated Articles of Incorporation in effect at the time of this amendment was: (i) 2/3rds of the outstanding Series A Preferred Stock voting separately as a class, and (ii) a majority of the outstanding shares of Common Stock and Preferred Stock, voting together as a single class.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
