**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), dated as of May 1, 2006, from Wells Fargo Foothill, Inc., a California corporation, located at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, California, 90404, in its capacity as Agent ("Agent") to WinZip International LLC, a Delaware limited liability company (the "Company"), located at 11 Professional Park Road, Mansfield, Connecticut 06268.

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement dated as of June, 29 2005, by Company in favor of Agent (the "Security Agreement"), a security interest was granted by the Company to Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 29, 2005, at Reel 003113 and Frame 0587; and

WHEREAS, Agent now desires to terminate the Security Agreement and release the security interest granted by Company pursuant to the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," shall have the meaning provided by reference in the Security Agreement (including, without limitation, those items listed on Schedule A hereto).

2. Release of Security Interest. Agent hereby terminates, releases and discharges its security interest in all of the Trademark Collateral, and any right, title or interest of Agent in, to and under such Trademark Collateral shall hereby cease and become void.
