## ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT AGREEMENT is made and effective as of the 11<sup>th</sup> day of May, 2006 by and between Paramount Pictures Corporation a Delaware corporation with principle offices at 5555 Melrose Avenue, Hollywood, California, 90038 ("Buyer") and Northfork Entertainment Corporation ("Seller"), a Delaware corporation, with principle offices at c/o Loeb & Loeb LLP, 345 Park Avenue, New York, New York, 10154.

WHEREAS, Seller owns all rights, title, and interest in and to (a) a federal trademark registration, U.S. No. 2,567,583 for the mark VANTAGE ENTERTAINMENT (the "Mark") for use in connection with education and entertainment services, namely script writing, producing and directing of motion picture films, television shows, video and audio recordings, live performances, theater productions, and television and radio programs for transmission via broadcast, cable, digital and global computer network, and publication of accompanying materials in the form of books, magazines, and newsletters; and (b) a California State trademark registration for the Mark, State Reg. No. 54735 for use in connection with educational and entertainment services, namely writing, producing, directing and development of creative material, including but not limited to motion pictures, television, video, publishing, music, theater and the Internet (collectively both the federal and state registrations are referred to hereinafter as the "Registrations"); and

WHEREAS, Buyer desires to acquire from Seller the Mark, the Registrations and the associated goodwill connected to the Mark and Registrations;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller hereby conveys, assigns, transfers and delivers to Buyer free and clear of all liens, claims and encumbrances, all right, title and interest in and to the Mark, each of the Registrations, and the goodwill of the business symbolized thereby and the Registrations thereof.





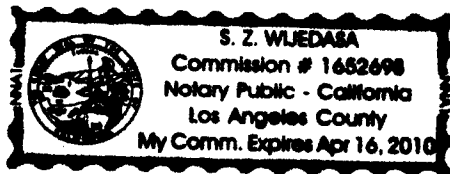
