## SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

This SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Second Lien IP Security Agreement”) dated February 16, 2006, is made by COVALENCE SPECIALTY MATERIALS CORP. (the “Borrower”), COVALENCE SPECIALTY ADHESIVES LLC (“Adhesives”), and COVALENCE SPECIALTY COATINGS LLC (together with the Borrower and Adhesives, the “Grantors”) in favor of Bank of America, N.A., as administrative agent (in such capacity, the “Administrative Agent”) for the Secured Parties (as defined in the Second Lien Credit Agreement referred to below).

WHEREAS, the Borrower, a Delaware corporation, has entered into a Second Lien Credit Agreement dated as of February 16, 2005 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Second Lien Credit Agreement”), with the Administrative Agent, the other agents party thereto and the Lenders party thereto.

WHEREAS, as a condition precedent to the making of Loans and the issuance of Letters of Credit by the Lenders under the Second Lien Credit Agreement by the Persons party thereto from time to time, each Grantor has executed and delivered that certain Second Lien Guarantee and Collateral Agreement dated February 16, 2006 to the Administrative Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Second Lien Collateral Agreement”). Terms defined in the Second Lien Collateral Agreement and not otherwise defined herein are used herein as defined in the Second Lien Collateral Agreement.

WHEREAS, under the terms of the Second Lien Collateral Agreement, each Grantor has granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of such Grantor, and has agreed under the Second Lien Credit Agreement to execute this Second Lien IP Security Agreement for recording with the United States Patent and Trademark Office, the United States Copyright Office (and any successor office or any similar office in any other country).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

SECTION 1. Grant of Security. Each Grantor hereby assigns and pledges to the Administrative Agent, its successors and permitted assigns, for the ratable benefit of the Secured Parties, and hereby grants to the Administrative Agent, its successors and assigns, for the ratable benefit of the Secured Parties, a security interest in all right, title and interest in or to any and all of the following assets and properties now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (the “Collateral”):

(a) the patents and patent applications set forth in Schedule A hereto (the “Patents”);

(b) the trademark and service mark registrations and applications set forth in Schedule B hereto (except for “intent-to-use” applications for trademark or service mark

registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an Amendment to Allege Use or a Statement of Use under Sections 1(c) and 1(d) of the Lanham Act has been filed, to the extent that any assignment of an “intent-to-use” application prior to such filing would violate the Lanham Act), together with the goodwill symbolized thereby (the “Trademarks”);

(c) all copyrights, whether registered or unregistered, now owned or hereafter acquired by such Grantor, including, without limitation, the copyright registrations and applications and exclusive copyright licenses set forth in Schedule C hereto (the “Copyrights”);

(d) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;

(e) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(f) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing.

SECTION 2. Security for Obligations. The grant of a security interest in the Collateral by each Grantor under this IP Security Agreement secures the payment or performance when due (whether at stated maturity, by acceleration or otherwise), as the case may be, in full of such Grantor’s Obligations

SECTION 3. Recordation. Each Grantor authorizes and requests that the United States Register of Copyrights, the United States Commissioner for Patents and the United States Commissioner for Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Second Lien IP Security Agreement.

SECTION 4. Execution in Counterparts. This Second Lien IP Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 5. Grants, Rights and Remedies. This Second Lien IP Security Agreement has been entered into in conjunction with the provisions of the Second Lien Collateral Agreement. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Administrative Agent with respect to the Collateral are more fully set forth in the Second Lien Collateral Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In


the event that any provision of this Second Lien IP Security Agreement is in conflict with the Second Lien Collateral Agreement or the Second Lien Credit Agreement, the provisions of the Second Lien Collateral Agreement or the Second Lien Credit Agreement, as the case may be, shall govern.

SECTION 6. Governing Law. This Second Lien IP Security Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.
