**TRADEMARK ASSIGNMENT OF SECURITY**

WHEREAS, Royal Consumer Information Products, Inc. WHEREAS, Borrower is obligated to LaSalle Business Credit, LLC (as successor in interest to LaSalle Business Credit, Inc.), as agent for Standard Federal Bank National Association (as successor to Michigan National Bank, as successor to Mellon Bank, N.A.) ("Lender") pursuant to (i) a certain Amended and Restated Loan and Security Agreement, dated as of September 23, 2004, between Lender and Borrower and (ii) a certain Trademark Collateral Security Agreement, dated the date hereof, made by Borrower in favor of Lender (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and



Borrower expressly acknowledges and affirms that the rights and remedies of Lender with respect to the assignment and security interest granted hereby are more fully set forth in the Agreements.


