RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), dated as of May 4, 2006, by Credit Suisse, Cayman Islands Branch (F/K/A Credit Suisse First Boston, Cayman Islands Branch), as Collateral Agent ("Agent"), grants a release of security interest in trademarks to AMF Bowling Worldwide, Inc. ("Borrower") as follows:

WHEREAS, Borrower and Agent are parties to a certain Security Agreement, dated as of February 27, 2004 (this agreement, as amended, restated, or otherwise modified, the "Security Agreement"); and

WHEREAS, pursuant to the Security Agreement, Borrower and Agent, and AMF Bowling Products, Inc. ("Products") and Agent, entered into Assignments of Security Interest in United States Patents and Trademarks dated February 27, 2004 (the "Patent and Trademark Security Interest Agreements") by which Borrower and Products granted to Agent a continuing security interest in, and continuing lien upon, among other things, all right, title, and interest of Borrower and Products in and to the trademarks and service marks listed on the attached **Schedule A**, together with all goodwill connected with the use of and symbolized by each, and all renewals thereof (the "Trademarks"), among other trademarks and service marks, which Patent and Trademark Security Interest Agreements were recorded with the United States Patent and Trademark Office ("USPTO") on March 18, 2004, at Reel/Frame No. 2813/0175; and

WHEREAS, the Trademarks are being licensed to Billiards Acquisition, Inc., now known as AMF Billiards & Games, Inc. ("Billiards") pursuant to a Trademark License Agreement dated December 5, 2005 between Billiards and Borrower (the "Trademark License Agreement"); and

WHEREAS, pursuant to the Security Agreement, Agent has released and has agreed to release its continuing security interest in, and continuing lien upon, the exclusive, perpetual license rights in the Trademarks and other license rights granted by Borrower to Billiards pursuant to the Trademark License Agreement (the "Released Security"), subject to the terms and conditions of this Release; and

WHEREAS, pursuant to the Security Agreement, Agent will retain a continuing security interest in, and continuing lien upon, the Patent and Trademark Collateral (as defined in the Patent and Trademark Security Interest Agreements) with the exception of the Released Security.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

1. Agent acknowledges and agrees that any right, title, or interest in the Trademarks that it may acquire pursuant to the Patent and Trademark Security Interest Agreements during the term of the Trademark License Agreement shall be subject to the

Trademark License Agreement and the trademark license and all other rights of Billiards set forth therein.

2. Agent hereby releases its continuing security interest in, and continuing lien upon, the Released Security.

3. This Release has been executed and delivered by Agent for the purpose of releasing, removing, or otherwise eliminating the security interest of the Agent in the Released Security described in the Patent and Trademark Security Interest Agreements that were filed with the USPTO and, to the extent required, any other such offices in other countries of the world. All of Borrower's obligations under the Patent and Trademark Security Interest Agreements as they pertain to the Released Security are thus terminated as of the date first set forth above.

4. Agent has a continuing obligation to sign all agreements, documents, or otherwise, necessary to carry out this Release and the obligations herein. In addition, the Agent hereby authorizes the Borrower to file this Release with the USPTO.

5. This Release shall be binding upon Borrower's legal representatives, successors, and assigns. Billiards is a third party beneficiary of this Release.

6. In the event that the Trademark License Agreement is terminated, Borrower hereby acknowledges and agrees that, at the written request of Agent, it will execute all agreements, documents and other instruments necessary to grant Agent for the benefit of the Finance Parties (as defined in the Security Agreement) a security interest in the Released Security.


