ASSIGNMENT OF TRADEMARKS AND ACCOMPANYING GOODWILL

WHEREAS, AMERICAN CORD & TWINE, INC., a North Carolina corporation (hereinafter referred to as the "Assignor"), has adopted, used and is the owner of various registered trademarks and trademark applications set forth on the attached Schedule A, and all rights applicable thereto, including, but not limited to, all common law rights, causes of action, and the right to recover for past infringement, dilution or other misappropriation (hereinafter collectively the "Trademarks");

WHEREAS, ROYAL AMERICAN COMPANY, L.L.C., a North Carolina limited liability company (hereinafter referred to as the "Assignee"), is desirous of acquiring the Trademarks, together with the good will associated therewith;

WHEREAS, in accordance with the terms of the Limited Liability Company Membership Interest Purchase Agreement dated as of April 5, 2006 among Wall Industries, Inc., Royal Acquisition Corporation, Assignor, Assignee, Royal Cordage Corporation, Jerry W. Webb and Lloyd Alwan, Assignee desires to obtain an assignment of Assignor's rights in the Trademarks and Assignor desires to assign its rights in the Trademarks to Assignee; and

WHEREAS, Assignee is the successor-in-interest to that portion of Assignor's business which pertains to the Trademarks;

NOW, THEREFORE, in consideration of the sum of One Hundred Dollars (\$100.00) and for other good and valuable consideration, the receipt and sufficiency of which Assignor acknowledges by its execution below:


1. Assignor hereby assigns to Assignee all of its rights, title and interest, in and to the Trademarks, in each case together with the goodwill of the business connected with the use of and symbolized by the Trademarks and that portion of Assignor's business which pertains to any pending intent-to-use applications filed pursuant to Section 1(b) of the United States Trademark Act (15 U.S.C. § 1051, *et seq.*).

2. Assignor agrees to perform all reasonable and proper additional acts and to execute any additional documents at the request and expense of Assignee which Assignee may require in order to vest all of Assignor's rights, title and interest in and to the Trademarks in Assignee, its successors or assigns.


