RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL ("Release") is made as of March 04, 2005, by Union Bank of California, N.A., a national banking association ("Bank") the secured party under that certain Security Agreement-Trademarks referred to below.

WITNESSETH, and

WHEREAS, Olympia Group, Inc. (collectively, the "Borrower"), executed that certain Security Agreement-Trademarks dated as of June 3, 2002, (the "Security Agreement"), pursuant to which Borrower granted to Bank a security interest in certain Collateral, as therein defined, including among other things certain trademarks and general intangibles owned by Borrower; and

WHEREAS, the Security Agreement was recorded on December 27, 2002 with the US Patent & Trademark Office against the trademark identified on Schedule A attached hereto and made a part hereof (the "Released Trademark"); and

WHEREAS, Bank has agreed to release all of its rights under the Security Agreement-Trademarks, including without limitation all of its rights in and to the Released Trademarks, and to reconvey to Borrower all of its rights in and to the Released Trademarks; and

NOW, THEREFORE, in consideration of the premises hereof, and other good and valuable consideration the receipt of which is hereby acknowledged, Bank hereby releases all of its rights in and to the Released Trademarks, reconveys to Borrower all of its right, title and interest in and to the Released Trademarks, releases all other rights it may have under the Security Agreement-Trademarks with respect to the Collateral, including the Released Trademarks, and cancels the Security Agreement-Trademarks in its entirety.

Bank hereby represents and warrants that it has not heretofore transferred to any other person or entity any of the rights in and to the Collateral that were granted to it pursuant to the Security Agreement-Trademark.

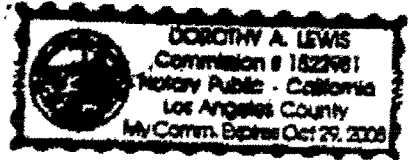
