TRADEMARK ASSIGNMENT

NOW, THEREFORE, be it known that, for and in consideration of the sum of twenty five thousand dollars (\$25,000.00) paid to Assignor by the said Assignee, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, by these present, does sell, assign and transfer unto said Assignee, its successors, assigns and legal representatives, the full and exclusive right, title and interest for the territory of the United States of America and all countries foreign thereto (including the right to apply for trademarks in foreign countries in its own name and to claim any priority rights for such foreign applications to which such applications are entitled under international conventions, treaties or otherwise), in and to the trademark "STAIN BLASTER" registered before the United States Patent and Trademark Office on December 2, 1997 as United States Trademark Registration No. 2.117.255, and Assignor thereby authorizes and requests the Commissioner for Trademarks transfer ownership of United States Registration No. 2.117.255 to said Assignee, as assignee of the entire right, title and interest.
