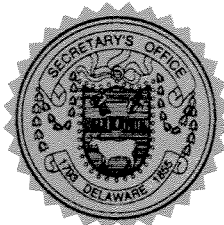


**CERTIFICATE OF AMENDMENT**
