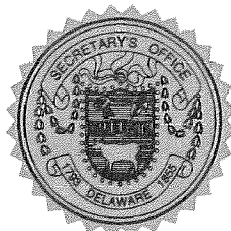

**CERTIFICATE OF AMENDMENT  
OF  
CERTIFICATE OF INCORPORATION**

Sippican, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY by the unanimous written consent of its members, filed with the minutes of the Board:

FIRST: That the Board of Directors of said Corporation, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said Corporation:

RESOLVED, that pursuant to Sections 228 and 242 of the General Corporation Law of the State of Delaware, the Board of Directors of the Corporation does hereby declare it advisable and in the best interest of the Corporation to amend the Certificate of Incorporation of the Corporation by changing the first Article thereof so that, as amended, said Article shall be and read as follows:

"FIRST: The name of the corporation (hereinafter sometimes referred to as the "Corporation") is: Lockheed Martin Sippican, Inc."

SECOND: That in lieu of a meeting and vote of stockholders, the stockholders have given unanimous written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.
