INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement dated as of March 31, 2006, is between PARAGON NATIONAL BANK ("Bank") and Merle F. ("Buck") Gardner ("Grantor").

RECITALS

A. Bank will make Loans ("Loans") to Grantor or Grantor's company, Buck Gardner Calls, LLC ("Borrower") as defined in the Loan Agreement (the "Loan Agreement") dated April 7, 2005, between Bank and Borrower, but only if Grantor grants Bank a security interest in his Copyrights and Trademarks.

B. Grantor has granted Bank a security interest in all of his right, title and interest, presently existing or later acquired to all of Grantor's Collateral, pursuant to a Security Agreement of even date herewith ("Grantor's Security Agreement"). Grantor has guaranteed the Loans.

C. Terms not otherwise defined herein shall be as defined in the Loan Agreement.


AGREEMENT

Grantor grants Bank a security interest in all of his right, title and interest in his presently existing and later acquired Intellectual Property. "Intellectual Property" shall mean: (a) Copyrights and Trademarks (as defined below), including amendments, renewals, extensions, and all licenses, or other rights to use and all license fees and royalties from the use; (b) all design rights which may be available to Grantor now or later created, acquired or held; (c) any claims for damages (past, present or future) for infringement of any of the rights above; with the right, but not the obligation, to sue and collect damages for use or infringement of the intellectual property rights above; and (d) all proceeds and products of the foregoing, including all insurance, indemnity or warranty payments. "Copyrights" shall mean all copyright rights, applications or registrations and like protections in each work of authorship or derivative work, whether published or not (whether or not it is a trade secret) now or later existing, created acquired or held by Grantor. "Trademarks" shall mean all trademarks, trade names, service marks, logos, and other source of business identifiers and designs owned by the Grantor, now existing anywhere in the world or hereafter adopted or acquired, and all goodwill of the business connected with the use of, and symbolized by, the foregoing, together with all registrations and recordings thereof and all applications filed in connection therewith in any office or agent of the United States of America (including the United States Patent and Trademark Office) or any foreign country, and including, without limitation, those referred to in Exhibit A attached hereto.

This security interest is granted in conjunction with the security interest granted under the Loan Agreement and Grantor's Security Agreement. Bank's rights and remedies in the security interest are in addition to those in the Loan Agreement and Grantor's Security Agreement, and those available in law or equity. Bank's rights powers and interests are cumulative with every right, power or remedy provided here. Bank's exercise of its rights, powers or remedies in this Agreement, or the Loan Agreement on Grantor's Security Agreement, does not preclude the simultaneous or later exercise of any or all other right, power or remedy.
