DOMESTIC INTELLECTUAL PROPERTY AND DOMAIN NAME ASSIGNMENT

This DOMESTIC INTELLECTUAL PROPERTY AND DOMAIN NAME ASSIGNMENT (this "Assignment"), effective the 26th day of February, 2005, is made and entered into by and among Tropical Sportswear Int'l Corporation, a Florida corporation having a place of business at 4902 West Waters Avenue, Tampa, Florida 33634-1302 ("TSIC"), TSI Brands, Inc., a Delaware corporation having a place of business at 4902 West Waters Avenue, Tampa, Florida 33634-1302 and an indirect wholly owned subsidiary of TSIC ("TSI Brands" and, together with TSIC, the "Assignors"), and PEI Licensing, Inc., a Delaware corporation having a place of business at 3000 N.W. 107th Avenue, Miami, Florida 33172 ("Assignee") and a wholly owned subsidiary of Perry Ellis International, Inc., a Florida corporation having a place of business at 3000 N.W. 107th Avenue, Miami, Florida 33172 ("Perry Ellis"). Capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in the Purchase Agreement (defined below).

WHEREAS, TSI Brands is the owner of each of (i) the patents and patent applications on Schedule A hereto; and (ii) the trademarks, trademark registrations and trademark applications (including any and all goodwill symbolized thereby) on Schedule B hereto and other Transferred Intellectual Property on Schedule A and Schedule B hereto ((i) and (ii), collectively, the "Purchased Intellectual Property");

WHEREAS, TSIC is the registrant of record and owner of each of the Internet domain names (including any and all goodwill symbolized thereby) on Schedule C hereto and the domain name registrations therefor (the "Domain Names"); and

WHEREAS, the Assignors, Savane International Corp., a Texas corporation and a wholly owned subsidiary of TSIC, Apparel Network Corp., a Florida corporation and a wholly owned subsidiary of TSIC, TSIL, Inc., a Delaware corporation and an indirect wholly owned subsidiary of TSIC, Farah Offshore Sourcing Company, a Cayman Islands corporation and an indirect wholly owned subsidiary of TSIC (collectively, the "Sellers"), Farah Manufacturing (U.K.) Limited, a United Kingdom private limited company, and Perry Ellis entered into that certain Asset Purchase Agreement dated as of December 16, 2004 (the "Purchase Agreement"), pursuant to which Perry Ellis agreed to purchase the Purchased Assets from the Sellers, including all of Sellers' right, title and interest in and to the Transferred Intellectual Property (as set forth in Section 2.01(a)(vii) of the Purchase Agreement) which includes the Purchased Intellectual Property and the Domain Names.

NOW THEREFORE, for the consideration set forth in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Effective as of 12:01 a.m., New York City time, on February 26, 2005 (the "Closing"): (a) (i) TSI Brands hereby assigns to Assignee all of its right, title and interest in and to the Purchased Intellectual Property set forth on Schedule A and Schedule B hereto, including all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement or misappropriations thereof, and (ii) TSIC hereby assigns to Assignee all of its right, title and interest in and to the Domain Names set forth

on Schedule C hereto, including all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement or misappropriations thereof (the rights, title and interest referred to in clauses (a)(i) and (a)(ii) hereof being collectively referred to as the "Transferred Rights"); (b) Assignors hereby assign to Assignee any and all rights to sue at law or in equity for any infringement, imitation, impairment, distortion, dilution or other unauthorized use or conduct in derogation of the Transferred Rights occurring prior to the Closing, including the right to receive all proceeds and damages therefrom; (c) Assignors hereby assign to Assignee any and all rights to royalties, profits, compensation, license fees or other payments or remuneration of any kind relating to the Transferred Rights; and (d) Assignors hereby assign to Assignee any and all rights to obtain renewals, reissues, and extensions of registrations or other legal protections pertaining to the Transferred Rights.

Assignee, and its successors and assigns, shall hold the rights to the foregoing for and during the existence of such Transferred Rights, and all renewals, reissues and extensions thereof, as fully and as entirely as the same would have been held and enjoyed by Assignors had this Assignment not been made. TSI Brands hereby covenants that it is the sole owner of the Transferred Rights associated with the Purchased Intellectual Property set forth on Schedule A and Schedule B hereto, and TSIC hereby covenants that it is the sole owner of the Transferred Rights associated with the Domain Names set forth on Schedule C hereto, in each case free and clear of any and all liens, security interests, claims or other encumbrances of any kind, and each of the Assignors covenants that it has full right to convey the entire interest herein assigned, and that it has not executed and will not execute, any agreements inconsistent herewith.

2. Registrant Name Change Agreement. Within five (5) days following Closing, TSIC shall (i) execute or otherwise complete the applicable registrant name change agreement or other forms required by the applicable Internet domain name registrar for each Domain Name (the "Registering Authority") to transfer such Domain Name to Assignee on an expedited basis, (ii) submit or file such registrant name change agreements or other forms to or with the Registering Authority in accordance with the policies and rules of the Registering Authority, and (iii) take any further actions in accordance with the policies and rules of the Registering Authority as required to transfer such Domain Names to Assignee on an expedited basis.

3. Further Assurances. Each Assignor shall, at the cost and expense of Assignee, timely execute and deliver any additional documents and perform such additional acts necessary or desirable to record and perfect the interest of Assignee in and to the Purchased Intellectual Property and the Domain Names, and shall not enter into any agreement in conflict with this Assignment.

4. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Florida, without regard to the conflicts of law rules of such state.

5. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same agreement.

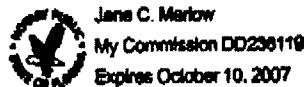

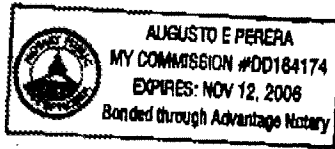
