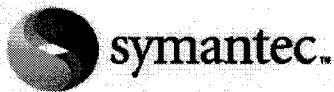

**SYMANTEC CORPORATION  
OFFICER'S CERTIFICATE**

Arthur F. Courville, Secretary of Symantec Corporation, a Delaware corporation ("Symantec"), does hereby certify to the United States Patent and Trademark Office ("Recipient") as follows:

1. I am the duly appointed Secretary of Symantec.
2. I have personal knowledge of, or have made or have caused to be made such investigations as are necessary in order to permit me to verify the accuracy of the information set forth in this Certificate.
3. On March 29, 1999, Symantec acquired all outstanding shares of Quarterdeck Corporation., a Delaware corporation, pursuant to that certain Agreement and Plan of Merger (the "Merger Agreement") dated October 15, 1998 by and among Symantec, Oak Acquisition Corporation and Quarterdeck Corporation, as a result of which Quarterdeck Corporation became a wholly-owned subsidiary of Symantec.
4. As a result of the transaction, Symantec acquired all assets of Quarterdeck Corporation and its subsidiaries and, subject to the terms and conditions of the Merger Agreement, assumed all rights and obligations of Quarterdeck Corporation, effective March 29, 1999, including all contracts and contractual rights and obligations.
5. On March 28, 2003, Quarterdeck Corporation was converted to a limited liability company ("Quarterdeck LLC").
6. Upon the conversion, Symantec elected to treat Quarterdeck LLC as a disregarded entity, as a result of which Quarterdeck LLC contributed all of its assets and liabilities to Symantec, such assets including, but not limited to, the entire right, title, and interest in all intellectual property owned and licensed by Quarterdeck LLC. As used herein, "intellectual property" can include, without limitation, patents, patent applications, copyrights, trademarks, service marks, logos, trade names, Internet domain names, trade secrets, contractual rights, other licenses, software, and distribution rights, among others.
7. On May 25, 2004, a Certificate of Cancellation of Quarterdeck LLC was filed with the Delaware Secretary of State, effecting the cancellation of Quarterdeck LLC following the dissolution and winding up of the company.
8. This Certificate contains a number of representations made on behalf of Symantec and is for the benefit of Recipient. Third parties cannot rely on the representations made in this Certificate without express written consent of Symantec.
