TRADEMARK ASSIGNMENT AGREEMENT

1. Seller hereby sells, assigns and transfers to Purchaser, its successors and assigns, as the successor to Seller's business to which the Marks pertain, all its right, title and interest in and to the Marks, including all common law rights, in the United States of America and all other countries and jurisdictions of the world, together with the goodwill of the business symbolized by the Marks.

2. Seller hereby assigns to Purchaser all causes of action, claims and rights to damages or profits, due or accrued, arising out of past infringement of the Marks, or injury to the goodwill associated with the Marks, as well as the rights to sue for and recover the Marks in Purchaser's own name.

3. Seller represents and warrants that it will cooperate (i) in any actions necessary for Purchaser to prosecute, renew or register its rights, title and interests in and to the Marks, including United States and foreign registrations, at Purchaser's expense (except to the extent that Parent and Seller are required to indemnify Purchaser pursuant to Section 3.01 of the Purchase Agreement for any of the above actions), and (ii) to cooperate in any actions brought to enforce the rights accompanying this Assignment against third parties, at Purchaser's expense (except to the extent that Parent and Seller are required to indemnify Purchaser pursuant to Section 3.01 of the Purchase Agreement for any of the above actions).
