RELEASE OF SECURITY INTEREST

BE IT KNOWN that the undersigned, **ROUND TABLE ACQUISITIONS INCORPORATED**, a New York corporation with its principal place of business at 333 East 68th Street, Suite 13A, New York, New York 10021 (the "Secured Party") for its benefit as a secured party pursuant to a certain Assignment of Security Interest in Trademarks between Secured Party and Chemical Bank New Jersey, National Association, dated August 22, 1996 and recorded at the United States Patent and Trademark Office on September 30, 1996 at REEL 1506, FRAME 0579 and the presently record holder of a security interest initially granted to Chemical Bank New Jersey, National Association, pursuant to a Collateral Assignment of Patents and Trademarks Agreement dated December 4, 1991, by **HOUBIGANT, INC.** (the "Grantor"), a Delaware corporation, with its principal place of business at 333 East 68th Street, Suite 13A, New York, New York 10021, does hereby fully, completely and without reservation of any kind, discharge, release and relinquish the Grantor, its successors and assigns, for the security interest held by Secured Party insofar as it related to all of Secured Party's right, title and interest in and to the trademarks and the trademark applications or registrations listed on the attached Schedule A together with all of Secured Party's right, title and interest, if any, in and to the goodwill associated with the trademarks.

If any term or provision of this Release is or shall become illegal, invalid or unenforceable in any jurisdiction, all other terms and provisions of this Release shall remain legal, valid and enforceable in such jurisdictions and such illegal, invalid or unenforceable provision shall be legal, valid and enforceable in any other jurisdiction.


Should the Grantor so desire, Secured Party shall execute a UCC-3 Financing Statement Change and other such documents as may be appropriate releasing the collateral described above.
