WHEREAS, pursuant to a Trademark Security Agreement (the "Security Document") between Sol Brothers, Inc., Una Mas, Inc., El Nino, Inc., El Grande, Inc., Mex On Smallman, Inc., Luna Bros., Inc., and Nunca, Inc. (hereinafter referred to as the "Debtors") and Royal Holding Company, Inc. (the "Lender") dated October 24, 1997, the Lender was granted a security interest or lien in the trademark and service mark properties identified in Schedule A attached hereto (the "Trademarks"), said Security Document recorded at the United States Patent and Trademark Office starting at Reel/Frame 1763/0458 on July 27, 1998;

Further, the Lender will execute any and all additional documents necessary to terminate and release all security interests in or liens on the Trademarks and deliver all such documents as Debtors shall request in order to evidence the release of the Lender's lien on any of Debtors' assets, including, without limitation, UCC-3's and releases with respect to any security interest of the Lender in Debtors' Trademarks or other intellectual property.
