The resulting bank title is United States Trust Company, National Association, and the charter number is 24645.

This is also the official authorization given to United States Trust Company, National Association, to operate the branches of the target bank and the main office of the target bank as a branch. The former main office of U.S. Trust Company, National Association, located at One Pickwick Plaza, Greenwich, Fairfield County, Connecticut 06830, is authorized as branch number 133960A and will be popularly known as the "USTC/CT" branch.



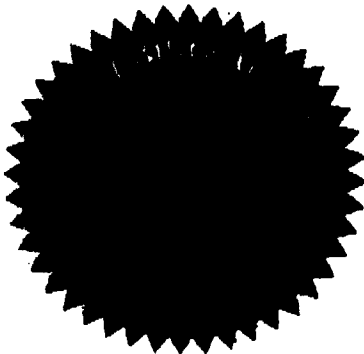


