RELEASE OF INTELLECTUAL PROPERTY COLLATERAL

THIS RELEASE OF INTELLECTUAL PROPERTY COLLATERAL (this "Release") is made as of May 25, 2006, by LASALLE BANK NATIONAL ASSOCIATION, as Administrative Agent ("Agent"), the secured party under that certain Security Agreement referred to below.

WITNESSETH:

WHEREAS, Management Insight Incentives, LLC, a Missouri limited liability company ("MII") executed that certain Security Agreement dated December 15, 2005, pursuant to which MII granted a security interest to Agent in all patents, patent applications, trademarks, trademark applications, trade secrets, trade names, service marks, trade styles, and copyrights owned by MII; and
