**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of May 11, 2006 ("Effective Date") by and between GE BUSINESS CAPITAL CORPORATION (F/K/A TRANSAMERICA BUSINESS CAPITAL CORPORATION), with its principal office at 500 W. Monroe Street, Chicago, Illinois 60661 ("Grantee"), and REPUBLIC STORAGE SYSTEMS COMPANY, INC., a Delaware corporation, with its principal office at 1038 Belden Ave., N.E. Canton, Ohio 44705 ("Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Grantor and Grantee dated January 14, 2003 (the "Intellectual Property Security Agreement"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor (collectively, the "Trademarks"), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, together with the goodwill associated therewith;

**WHEREAS**, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on January 27, 2003, at Reel 2658, Frame 0486; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Intellectual Property Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks, including, without limitation, those listed on Schedule A hereto.


