TRADEMARK SECURITY AGREEMENT, dated as of December 23, 2004, among SCIENTIFIC GAMES CORPORATION (the "Borrower"), the subsidiaries of the Borrower listed on Schedule I hereto, Scientific Games Royalty Corporation, MDI Entertainment LLC and JPMORGAN CHASE BANK, N.A., as Administrative Agent (the "Administrative Agent").

Reference is made to the Guarantee and Collateral Agreement dated as of December 23, 2004 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Borrower and the Guarantors party thereto in favor of the Administrative Agent. The Lenders have agreed to extend credit to the Borrower subject to the terms and conditions set forth in the Credit Agreement dated as of December 23, 2004 (as amended, supplemented or otherwise modified from time to time (the "Credit Agreement")). The obligations of the Lenders to extend such credit are conditioned upon, among other things, the execution and delivery of this Agreement. The Guarantors are affiliates of the Borrower, will derive substantial benefits from the extension of credit to the Borrower pursuant to the Credit Agreement and are willing to execute and deliver this Agreement in order to induce the Lenders to extend such credit. Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement. The rules of construction specified in Section 1.01(a) of the Security Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. (b) all goodwill associated with or symbolized by the Trademarks.


**SECTION 3. 
