## **CONFIRMATORY TRADEMARK ASSIGNMENT**

THIS ASSIGNMENT is made by and between PUBEASY.COM, INC., a Delaware corporation whose principal place of business is 80 Cottontail Lane, Somerset, NJ 08873 (hereinafter referred to as "Assignor"), and PubNet LLC., a Delaware limited liability company, whose principal place of business is 630 Central Avenue, New Providence, NJ 07974 (hereinafter referred to as "Assignee").

NOW, THEREFORE, for good and valuable consideration, previously paid by Assignee to Assignor, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign, set over and transfer unto said Assignee, *nunc pro tunc*, as of May 12, 2003, all right, title and interest in and to the ASSIGNED TRADEMARKS and the identified registrations therefor, together with the whole of the goodwill and the business symbolized by the ASSIGNED TRADEMARKS, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made; together with all claims for damages by reason of past infringement of the ASSIGNED TRADEMARKS, and with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns or other legal representatives.

THE ASSIGNOR agrees to execute all papers and to do all necessary things, at Assignee's expense, to ensure that Assignee acquires full rights, title and interest in and to the ASSIGNED MARKS.

IN TESTIMONY THEREOF, said Assignor has caused its name to be signed and its seal to be affixed, by its duly authorized officer, this 23<sup>rd</sup> day of May, 2004.
