Senior Agent and Subordinated Agent hereby release the Memorandum and acknowledge and affirm that the Memorandum has no further force or effect.



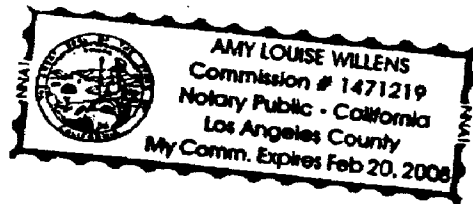
