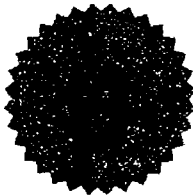

**CERTIFICATE OF MERGER
OF
RIVERBEND TIMBER FRAMING, INC.
WITH AND INTO
INSULSPAN OF AMERICA, INC.**

(Pursuant to 8 Del. C. §252)

The undersigned corporation incorporated and existing under and by virtue of the Delaware General Corporation Law:

DOES HEREBY CERTIFY:

FIRST: The name and jurisdiction of incorporation of each of the constituent entities which are to merge are as follows:

- (a) Insulspan of America, Inc., a Delaware corporation ("Insulspan" or the "Surviving Corporation") and
- (b) Riverbend Timber Framing, Inc., a Michigan corporation ("Riverbend")

SECOND: An Agreement and Plan of Merger (the "Merger Agreement") has been approved, adopted, certified, executed and acknowledged in accordance with Section 450.1735 of the Michigan Business Corporation Act, and Section 252 of the Delaware General Corporation Law, 8 Del. C. § 101, et seq. (the "DGCL")

THIRD: The name of the Surviving Corporation shall be changed to Insulspan, Incorporated, a Delaware corporation and Article First of the Certificate of Incorporation of Insulspan shall be deemed amended to reflect this name change.

FOURTH: The Surviving Corporation is a corporation of the State of Delaware

FIFTH: The Certificate of Incorporation of Surviving Corporation, in effect as of the effective time of the Merger and as amended hereby shall be the certificate of incorporation of the Surviving Corporation, except that upon the effective time of the Merger, Article First of the Certificate of Incorporation shall be amended to change the name of the Surviving Corporation to Insulspan Incorporated.


SIXTH: The executed Merger Agreement is on file at the principal place of business of the Surviving Corporation. The address of the principal place of business of the Surviving Corporation is 245 North Jipson Avenue, Blissfield, Michigan

SEVENTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of Insulspan and to any stockholder of Riverbend.

EIGHTH: The capital stock of Riverbend is 18,582 common shares.
