the \_\_\_ day of December, 2002, duly adopted the following resolutions:

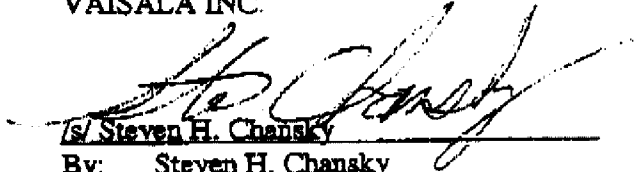

RESOLVED: That the merger of Vaisala-GAI with and into the Corporation shall be effective January 1, 2003.
