FIRST: That the Corporation was incorporated on the 29th day of May, 1981, pursuant to the General Corporation Law of the State of Delaware.

THIRD: That the Board of Directors of the Corporation, acting by written consent dated the ___ day of December, 2002, duly adopted the following resolutions:

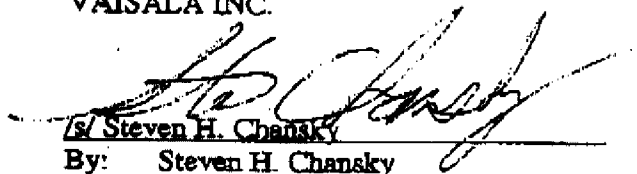

RESOLVED: That the merger of Vaisala-GAI with and into the Corporation shall be effective January 1, 2003.
