RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of May 31, 2006 ("Effective Date") by and between NES Equipment Services Corporation (formerly known as Albany Ladder Company, Inc.), an Illinois corporation with its principal office at 8770 W. Bryn Mawr, 4th Floor, Chicago, Illinois 60631 ("Grantor"), and Wachovia Bank, National Association, a national banking corporation (formerly known as First Union National Bank and First Union Commercial Corporation) ("Grantee").

WHEREAS, pursuant to the terms and conditions of those certain Security Agreements dated July 17, 1998 and August 6, 1999 (the "Security Agreements") with Grantee and Grantor, Grantor granted to Grantee a continuing security interest in, and continuing lien upon, the trademark registrations and applications set forth on Schedule A attached hereto, together with the goodwill associated therewith (collectively, the "Trademarks");

WHEREAS, the Security Agreements were recorded in the Trademark Division of the United States Patent and Trademark Office on July 22, 1998 at Reel 1761 and Frame 0043, and on November 20 2002, at Reel 2624 and Frame 0005; and


WHEREAS, Grantor has paid all of the outstanding indebtedness to Grantee pursuant to which the Security Agreements relate.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates, cancels and releases any and all security interests it has against the Trademarks.
