**TRADEMARK ASSIGNMENT**

This Trademark Assignment ("Assignment") is made and entered into as of April 10, 2006, by and between MYLAN LABORATORIES INC., a Pennsylvania corporation, with its principal place of business at 1500 Corporate Drive, Suite 400, Canonsburg, Pennsylvania 15317 ("Assignor"), and INALCO S.p.A., a corporation organized and existing under the laws of Italy, with its principal place of business at Via Calabiana, 18, Milano, Italy ("Assignee"). Assignor and Assignee are sometimes referred to collectively herein as the "Parties" and individually as a "Party".

WHEREAS, contemporaneous with the execution of this Assignment, Assignor and Assignee are executing a Trademark Purchase and Assignment Agreement to which this Assignment is referenced and attached;

WHEREAS, Assignor is the owner of all right, title and interest in and to the United States Registered Trademark KRISTALOSE, Registration No. 2,439,494 ( the "Trademark" or "Registration"), together with the goodwill of the business connected with and symbolized by the Trademark; and

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Trademark.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties hereby agree as set forth below.

Assignor hereby sells, assigns, transfers and conveys to Assignee the entire right, title, interest in and to the Trademarks in the United States, together with the goodwill of the business connected with and symbolized by the Trademark (including, without limitation, the right to renew any registrations included in the Trademark, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademark, and any priority right that may arise from the Trademark), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office to record the transfer of the Registration to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademarks.

This Trademark Assignment Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document.

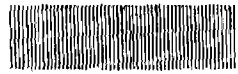
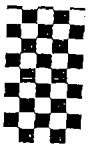

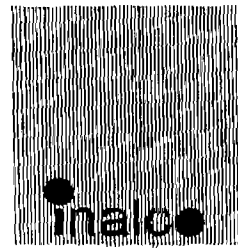
