RELEASE OF INTELLECTUAL PROPERTY COLLATERAL

THIS RELEASE OF INTELLECTUAL PROPERTY COLLATERAL (this "Release") is made as of May²⁵, 2006, by LASALLE BANK NATIONAL ASSOCIATION, as Administrative Agent ("Agent"), the secured party under that certain Security Agreement referred to below.

WITNESSETH:

WHEREAS, TBT Enterprises, Incorporated, a Maryland corporation ("TBT") executed that certain Security Agreement dated October 15, 2004, pursuant to which TBT granted a security interest to Agent in all patents, patent applications, trademarks, trademark applications, trade secrets, trade names, service marks, trade styles, and copyrights owned by TBT; and

WHEREAS, pursuant to that certain Third Amended and Restated Loan Agreement dated on or about the same date herewith entered into by TALX Corporation, a Missouri corporation, Agent, and Lenders (as defined therein), Agent and Lenders have agreed to release all of their rights under such Security Agreement with respect to the intellectual property identified on Schedule A attached hereto and made a part hereof (the "Released Collateral"), and to convey any and all rights in the Released Collateral to TBT.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby releases all its rights in and to the Released Collateral, conveys to the persons legally entitled thereto all of Agent's right, title and interest in and to the Released Collateral, releases all other rights it may have under said Security Agreement with respect to the Released Collateral, all without warranty or representation of any kind.
