Exhibit DTRADEMARK ASSIGNMENT AGREEMENT

Trademark Assignment Agreement, dated as of May 26, 2006 (this "**Agreement**"), between Dr Pepper/Seven Up, Inc., a Delaware corporation (the "**Assignor**"), and The ICEE Company, a Delaware corporation (the "**Assignee**"). Capitalized terms used herein but not defined herein shall have the meanings ascribed to such terms in the Purchase Agreement (as defined below).

WHEREAS, Assignor and Assignee have entered into a certain Asset Purchase Agreement, dated as of the date hereof (the "**Purchase Agreement**"), providing for, among other things, the sale, assignment, transfer, conveyance and delivery by Assignor of all of Assignor's right, title and interest in, to and under the marks and/or trade names set forth on Schedule A hereto, together with the goodwill of the businesses associated therewith (collectively, the "**Marks**").

NOW, THEREFORE, in consideration of the representations, warranties, covenants and agreements contained in the Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to the Purchase Agreement, the parties hereto hereby agree as follows:

1. Assignment. The Assignor hereby sells, assigns, transfers, conveys and delivers to the Assignee all of Assignor's right, title, and interest in, to and under the Marks.
2. Rights and Privileges. All rights and privileges held by the Assignor in the Marks, including the right to sue for and receive all damages from past infringements of the Marks, shall be held and enjoyed by the Assignee and its successors and assigns.
3. Further Assurances. The Assignor agrees to execute and deliver at any future date any additional documents that the Assignee reasonably determines are required to perfect the Assignee's ownership of or title to the Marks.
4. Authorization. The Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration of trademarks, to record the Assignee as the assignee and owner of any and all of the Assignor's rights in the Marks.
5. Governing Law. This Agreement shall be governed by and interpreted and enforced in accordance with the Laws of the State of New York, without giving effect to any choice of Law or conflicts of Law rules or provisions (whether of the State of New York or any other jurisdiction) that would cause the application of the Laws of a jurisdiction other than the State of New York.


6. Entire Agreement. This Agreement, together with the Purchase Agreement and its exhibits and schedules, set forth the entire understanding of the parties hereto with respect to the transactions contemplated by this Agreement.

7. Counterparts. This Agreement may be executed in counterparts, and any party hereto may execute any such counterpart, each of which when executed and delivered shall be deemed to be an original and all of which counterparts taken together shall constitute but one and the same instrument. This Agreement shall become effective when each party hereto shall have received a counterpart hereof signed by the other party hereto. The parties agree that the delivery of this Agreement may be effected by means of an exchange of facsimile or electronically transferred signatures.
