**TRADEMARK RELEASE**

This TRADEMARK RELEASE is made as of June 2, 2006, by GE COMMERCIAL DISTRIBUTION FINANCE CORPORATION ("GE").

WITNESSETH:

WHEREAS, GE and GTSI Corp. ("Grantor"), entered into that certain Trademark Security Agreement dated as of October 20, 2003 (the "Trademark Security Agreement"), pursuant to which Grantor granted a security interest to the GE in, among other things, the trademarks set forth on Schedule 1 attached hereto (the "Trademarks"); and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 22, 2003, at Reel 2848, Frame 0640; and

WHEREAS, the obligations underlying the security interests are no longer owed, and GE no longer has no further interest in the Trademarks and the other collateral described in the Trademark Security Agreement; and

WHEREAS, Grantor has requested that GE release its lien on the Trademarks and reassign the same to Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, GE hereby releases any and all claims, liens, security interests and other encumbrances arising under the Trademark Security Agreement and reassigns any and all rights, titles and interests conveyed thereunder, without any representation, recourse or undertaking by GE to Grantor.
