RELEASE OF INTEREST IN PATENTS, TRADEMARKS AND LICENSES

THIS RELEASE is made as of the _____ day of _____, 20____, by BANK OF AMERICA, N.A., AS SUCCESSOR IN INTEREST TO BANK OF AMERICA NATIONAL TRUST AND SAVINGS ASSOCIATION, AS AGENT, with an office in Chicago, Illinois 60697 (the "Bank") with respect to certain assets of BARNEBEY & SUTCLIFFE CORPORATION ("Assignor").

RECITALS

Bank and Assignor entered into a Loan and Security Agreement (the "Security Agreement") dated as of May 19, 1998, and a Trademark Assignment on June 5, 1998 (the "Assignment") for the purpose of securing the complete and timely satisfaction of all Assignor's liabilities under the Security Agreement, among other things. The Assignment involved a pledge of certain intellectual property, including without limitation the trademarks listed on Schedule A attached hereto (collectively, as defined in the Assignment, the "Collateral").

On June 27, 2003, Barnebey Sutcliffe Corporation (successor in interest to Assignor) filed a voluntary petition in the United States Bankruptcy Court for the District of Delaware, along with certain affiliates (collectively, the "Debtors").

On December 16, 2003, the Debtors filed the Debtors' Motion Pursuant to 11 U.S.C. §§ 105, 363 and 365 for Order Authorizing (a) Sale of Certain Assets of the Estates Free and Clear of Liens, Claims and Equity Interests, and (b) Assumption and Assignment of Certain Leases and Executory Contracts (the "Sale Motion"). Pursuant to an Order dated December 24, 2003, the Court established bid procedures and scheduled an auction and a hearing with respect to the Sale.

On or about February 9, 2004, after notice and a hearing on the Sale Motion, the Court entered an order approving the sale (the "Sale") to Calgon Carbon Corporation of substantially all of the assets of Debtors, free and clear of any claims or interests, including the claims of the Bank. On February 18, 2004, the Sale was consummated.

THEREFORE, the parties hereto, intending to be legally bound, hereby agree as follows:

1. The Bank hereby releases, terminates, waives, relinquishes, and forever discharges any and all security interests, rights, liens, privileges, title and interest whatsoever it has in the Collateral.

2. The provisions of this Agreement are severable, and if any clause or provision shall be held invalid and unenforceable in whole or in part in any jurisdiction, then such invalidity or unenforceability shall affect only such clause or provision, or part thereof, in such jurisdiction, and shall not in any manner affect such clause or provision in any other jurisdiction, or any clause or provision of this Agreement in any jurisdiction.
