deem necessary or desirable for securing or maintaining for ASSIGNEE the Trademark hereby assigned, all without further compensation to ASSIGNOR.

ASSIGNEE hereby accepts the sale, assignment, transfer and conveyance of the Trademark and the associated goodwill.

ASSIGNOR retains no ownership rights in the Trademark transferred to ASSIGNEE by this assignment.
