**CONFIRMATION OF  
TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This CONFIRMATION OF TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Confirmation") is executed and delivered as of the 6th day of June, 2006 by Bank of America, N.A., as successor by merger to Fleet National Bank ("Bank") to R&R Operating Partnership, L.P., a Pennsylvania limited partnership (the "Company").

**BACKGROUND**

A. Pursuant to a Loan, Reimbursement and Security Agreement dated as of July 15, 2002, (the "Agreement"), a security interest was granted to Bank by the Company in the trademarks set forth on Exhibit A attached hereto and made apart hereof (collectively, the "Marks"), and said security interest was recorded with the U.S. Patent and Trademark Office ("US PTO") at Reel/Frame 2549/0774.

B. All of the obligations in connection with the Agreement have been satisfied and discharged as evidenced by that certain Termination Agreement dated June 15, 2004 between Bank and the Company.

NOW THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

1. Bank hereby confirms the termination and release of all of its right, title and interest in the Marks.
2. The Company, or its designee, may record this Confirmation in the US PTO and in any other trademark offices as may necessary to carry out the intentions of this Confirmation.
3. Bank agrees to execute and deliver such other documents as may be reasonably requested and prepared by the Company, or its designee, to carry out the intentions of this Confirmation.
