RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") dated May 12, 2006 is made by WACHOVIA BANK, NATIONAL ASSOCIATION, 301 South College Street, NC0760, Charlotte, North Carolina, 28288-0760, acting in its capacity as agent for the Secured Parties referred to in the Agreements identified below (in such capacity, the "Agent") under a Trademark Collateral Agreement and a Trademark Collateral Agreement and Notice, both dated March 9, 2004, (the "Agreements"), by and between SUSQUEHANNA KANSAS CITY PARTNERSHIP, a Pennsylvania general partnership, ("Borrower") and the Agent.
