ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS (the "Assignment") is made as of May 22, 2006, by Mother's Food Products, Inc., a New Jersey corporation (the "Assignor"), to and in favor of R.A.B. Food Group, LLC, a Delaware limited liability company (the "Assignee").

WHEREAS, the Assignor and the Assignee are parties to the Asset Purchase Agreement, dated as of May 22, 2006 (the "Asset Purchase Agreement"), by and among the Assignee, the Assignor, Rokeach Acquisition LLC, a Delaware limited liability company, C.B. Holdings I Corp., a Delaware corporation, Rokeach Food Corporation, a New Jersey corporation, Joyce Food, L.L.C., a New Jersey limited liability company, the Victor Ostreicher Irrevocable Trust, Howard Freundlich, a New York resident, and Victor Ostreicher, a New York resident; and

WHEREAS, the Assignor is the owner of the registrations in the U.S. Patent and Trademark Office set forth in Schedule A annexed hereto (the "Trademarks"); and

WHEREAS, as required by the Asset Purchase Agreement, the Assignor is required to enter into this Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby transfer, convey, assign and deliver to the Assignee all right, title and interest of Assignor in and to the Trademarks and the registrations and applications therefor, and all of the goodwill of the Business associated with each such Trademark, together with the right to bring suit and collect for past infringements thereof.

All capitalized terms used in this Assignment, which are not defined herein, shall have the meanings ascribed thereto in the Asset Purchase Agreement.

Nothing contained in this Assignment shall itself change, amend, extend or alter (nor shall it be deemed or construed as changing, amending, extending or altering) the terms or conditions of the Asset Purchase Agreement in any manner whatsoever. In the event of any conflict or incompatibility between the Asset Purchase Agreement and this Assignment, the provisions of the Asset Purchase Agreement shall govern and control.

This Assignment shall be governed in all respects, including but not limited to, as to validity, interpretation and effect, by the internal laws of the State of New York, without giving effect to the conflict of laws rules thereof (to the extent such principles or rules are not mandatorily applicable by statute or would require or permit the application of the laws of another jurisdiction).




