RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST is made this 12th day of May, 2006, by GENERAL ELECTRIC CAPITAL CORPORATION, in its capacity as administrative agent for the Lenders (as defined in the Credit Agreement described below) (the "Administrative Agent") in favor of those parties listed as Grantors in the Trademark Security Agreement (as defined below) (collectively, the "Grantors").

WITNESSETH:

WHEREAS, reference is hereby made to that certain Second Amended, Restated and Consolidated Credit and Guaranty Agreement dated as of May 21, 2004 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") among Gabriel Communications Finance Company, a Delaware corporation ("Finance"), Newsouth Communications Corp., a Delaware corporation ("NewSouth") (Finance and NewSouth are collectively referred to therein as "Borrowers"), NuVox, Inc. (formerly known as Gabriel Communications, Inc.), a Delaware corporation ("Parent"), certain other direct and indirect subsidiaries of Parent as guarantors, the financial institutions party thereto, as lenders (the "Lenders"), and the Administrative Agent; and

WHEREAS, as a condition to the execution of the Credit Agreement by the Lenders, each of the Grantors has executed and delivered to the Administrative Agent, for the benefit of the Lenders, that certain Second Amended and Restated Pledge and Security Agreement dated as of May 21, 2004 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Pledge and Security Agreement");

WHEREAS, in connection with the Pledge and Security Agreement and the Credit Agreement, each of the Grantors executed and delivered to the Administrative Agent, for the benefit of the Lenders, the Trademark Security Agreement, dated May 21, 2004 (the "Trademark Security Agreement"), for recording in the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on June 17, 2004 at Reel/Frames 2994/0461, 2994/0473, 2994/0513, and 2994/0554;

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in the Trademark Collateral, as defined in the Trademark Security Agreement, and assign, transfer, and grant all of its right, title and interest in the Trademark Collateral to the Grantors;

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Pledge and Security Agreement.

2. RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL. The Administrative Agent hereby releases to the Grantors its security interest in all of such Administrative Agent's right, title and interest in, to and under the Trademark Collateral, including, without limitation, the trademarks and trademark applications listed on Schedule I.
