## ASSIGNMENT OF TRADEMARK

NOW THEREFORE for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, Assignor assigns and transfers unto Assignee all right, title and interest in and to the said mark and the registration therefor for the United States and throughout the world together with the goodwill of the business in connection with which the said mark is used and which is symbolized by the said mark, along with the right to recover for damages and profits for past infringements thereof.

Assignor agrees to execute and deliver at the request of Assignee all papers, instruments and assignments and to perform any other reasonable acts Assignee may require in order to vest all Assignor's rights, title and interest in and to the said mark in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee to the extent such evidence is in the possession or control of Assignor.
