**PURCHASE AGREEMENT**

THIS PURCHASE AGREEMENT ("*Purchase Agreement*") is made and entered into as of March 5, 2006 (the "*Effective Date*"), by and between EA Mobile LLC, a Delaware limited liability company ("*Seller*") and Electronic Arts Inc., a Delaware corporation ("*Purchaser*"). Seller and Purchaser are sometimes collectively referred to herein as the "*Parties*". Unless separately defined in this Purchase Agreement, all capitalized terms herein shall have the meanings ascribed to them in the Agreement (as defined below).

**WITNESSETH**

WHEREAS, pursuant to that certain Agreement and Plan of Merger among Purchaser, JAMDAT Acquisition Corp. and JAMDAT Mobile Inc., dated December 8, 2005, as amended (the "*Agreement*"), JAMDAT Mobile Inc. became a direct wholly-owned subsidiary of Purchaser. Upon consummation of the merger pursuant to the Agreement, JAMDAT Acquisition Corp. was merged into JAMDAT Mobile Inc. with JAMDAT Mobile Inc. as the surviving corporation and renamed "EA Mobile Inc." Thereafter EA Mobile Inc. converted to a Delaware limited liability company and changed its name to "EA Mobile LLC" and continues its existing business as a limited liability company;

WHEREAS, to further the Parties' business purposes and for good and sufficient consideration, the receipt and sufficiency of which is hereby acknowledged, Purchaser wishes to obtain by assignment, and Seller wishes to assign to Purchaser, all right, title and interest in the Intellectual Property of Company at Closing; and

WHEREAS, to give effect to the purpose of the Parties, Seller will execute the Intellectual Property Assignment Agreement set forth in Exhibit A hereto.

NOW, THEREFORE, the Parties agree as follows:

1. Transfer of Assigned IP Assets. Seller does hereby sell, transfer, assign, convey and deliver to Purchaser its entire right, title and interest in, to and under the Assigned IP Assets, as that term is defined in the Intellectual Property Assignment Agreement set forth in Exhibit A hereto and incorporated herein by reference.
2. Payment. Purchaser will pay Seller Ten Thousand U.S. Dollars (\$10,000.00). If any amount paid by Purchaser to Seller pursuant to this section is adjusted by any governmental tax authority pursuant to a final determination by administrative or judicial action, Purchaser shall pay to Seller, or Seller shall pay to Purchaser, as the case may be, the full amount of such adjustment.
3. Further Documents. If at any time after the Effective Date, any further action is necessary or desirable to carry out the purposes of this Purchase Agreement, Seller agrees to execute and deliver to Purchaser such further instruments as may be reasonably required to carry out or effectuate the purposes and intent of this Purchase Agreement and to vest in Purchaser full

right, title and interest in and to the Assigned IP Assets. Without limiting the foregoing, Purchaser and Seller shall execute and deliver the Intellectual Property Assignment Agreement attached hereto as Exhibit A.

4. Substitution and Subrogation. The assignment, transfer and conveyance contained herein is made with full powers of substitution and subrogation of Purchaser in and to all covenants and warranties heretofore given or made by third parties to Seller in respect of the Assigned IP Assets.

5. Binding Effect. This Purchase Agreement shall bind and inure to the benefit of the respective Parties and their successors, assigns, and transferees.

6. Governing Law. This Purchase Agreement shall be construed and enforced in accordance with the laws of the State of California without giving effect to the principles of choice of law or conflicts of law thereof.

7. Counterparts. This Purchase Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of such counterparts together shall constitute one and the same instrument.

### INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement ("*Assignment Agreement*") is entered into as of March 5, 2006 (the "*Effective Date*"), by and between EA Mobile LLC, a Delaware limited liability company ("*Seller*") and Electronic Arts Inc., a Delaware corporation ("*Purchaser*"). Purchaser and Seller are sometimes collectively referred to herein as the "*Parties*". Unless separately defined in this Assignment Agreement, all capitalized terms herein shall have the meanings ascribed to them in the Agreement (as defined below).

#### RECITALS

WHEREAS, pursuant to that certain Agreement and Plan of Merger among Purchaser, JAMDAT Acquisition Corp. and JAMDAT Mobile Inc., dated December 8, 2005, as amended (the "*Agreement*"), JAMDAT Mobile Inc. became a direct wholly-owned subsidiary of Purchaser. Upon consummation of the merger pursuant to the Agreement, JAMDAT Acquisition Corp. was merged into JAMDAT Mobile Inc. with JAMDAT Mobile Inc. as the surviving corporation and renamed "EA Mobile Inc." Thereafter EA Mobile Inc. converted to a Delaware limited liability company and changed its name to "EA Mobile LLC" and continues its existing business as a limited liability company; and

WHEREAS, to further the Parties' business purposes and for good and sufficient consideration, the receipt and sufficiency of which is hereby acknowledged, Purchaser wishes to obtain by assignment, and Seller wishes to assign to Purchaser, all right, title and interest in the Intellectual Property of Company at Closing;

Now, therefore, the Parties agree as follows:

1. Assignment of Intellectual Property. Seller hereby assigns to Purchaser all of Seller's right, title and interest, of whatever kind and nature forever and throughout the universe, including all causes of action, in either law or equity, for past, present, and future claims, in and to the Company IP Rights, including the Company-Owned IP Rights and the Company Registered Intellectual Property set forth on Schedule A attached hereto (trademark applications and registrations); Schedule B attached hereto (copyright registrations and applications); Schedule C attached hereto (patents and patent applications); and Schedule D attached hereto (domain name registrations), and all rights to receive any of the foregoing, rights corresponding to the foregoing, and all proceeds thereof (the "*Assigned IP Assets*"). Seller represents that Seller has all of the rights, titles, and interests to convey the Assigned IP Assets as set forth herein, and covenants that Seller has not made any assignment, grant, mortgage, license, or other agreement affecting the rights, titles, and interests herein conveyed except as may have occurred within the ordinary course of Seller's business as consistent with past practice of Company and Company Subsidiaries.

2. Authorizations. Seller hereby authorizes the Registrar of Copyrights of the United States and other empowered officials of the United States Copyright Office and the appropriate empowered officials or issuing authorities in relevant jurisdictions outside the United States to record the transfer of all registrations for copyrights included in the Assigned IP Assets to Purchaser as assignee of Seller's entire right, title and interest therein, and to issue to Purchaser all copyright registrations referred to above which may issue with respect to such Assigned IP Assets in or outside the United States, in accordance with this Assignment Agreement. Seller will cooperate with Purchaser to transfer ownership and management of domain names to Purchaser or its designee pursuant to the current procedures promulgated by the appropriate domain name registrar for modifying a domain record.





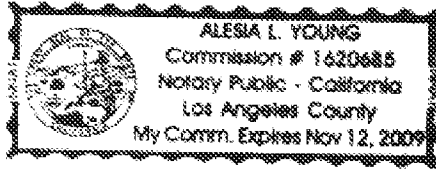
