NOTICE OF SECURITY INTEREST IN U.S. TRADEMARKS

Please be advised that pursuant to a Junior Security Agreement dated as of March 13, 2006 (the "Security Agreement") by ABELCONN, LLC, a Delaware limited liability company f/k/a AC Acquisition Company, LLC ("Grantor"), for the benefit of CFB Venture Fund, L.P. – Series IV, a Delaware limited partnership ("CFB"), as agent for itself and for Argosy Investment Partners II, L.P., a Delaware limited partnership ("Argosy"), Marquette Capital Fund I, LP, a Delaware limited partnership ("Marquette"), Hickory Venture Capital Corporation, an Alabama corporation ("Hickory") and Clifford L. 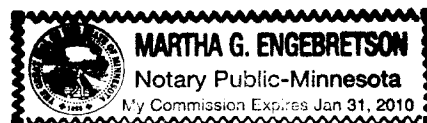
